**'isiza seshishini'** kusingisele kwisiza esisetenziselwa injongo engaphandle kwaleyo yokuhlala, kwaye ikhuphela ngaphandle oku kulandelayo –

- (a) izibhedlele, iikliniki amaziko abantu abagula ngengqondo angasetyenziselwa inzuzo yemali;

- (b) imizi yogcino lwembali, igumbi lokubonisa imisebenzi yobugcisa, amathala eencwadi kanye nesitiya sezityalo ezibhaliswe ngamagama abantu babucala kwaye avulelekileyo kuluntu, nokokuba imali yokungena iyahlawuliswa okanye ayihlawuliswa;
- (c) amabala ezemidlalo yebhola kulungiselela injongo yemidlalo yabo basaqalayo nezinye izinto ezonwabisayo ehlangene kanye nemidlalo enjalo;
- (d) nasiphi na isakhiwo esibhaliswe egameni leziko okanye lombutho, ngokokubona ngokufaneleyo kukumasipala, iqhuba imisebenzi yokuliza abangathathi-ntweni;
- (e) nasiphi na isakhiwo esinyanisekileyo secawa okanye sokuqhoba inkonzo;

**'igosa eliyintloko kwezemali'** kusingisele kwigosa elinoxanduva lokuphendula nelinoxanduva kumanejala kamasipala lokufezekisa, ukulawula nokunyanelisa umgaqo-nkqubo wolawulo lwamatyala akwamasipala kanye nokuqokelelwa kwamatyala;

**'ulawulo lwamatyala'** kusingisele kwimisebenzi ephathelele kuqokelelo lweemali ezifanele ukuhlawulwa ngabanamatyala;

**'umsebenzisi wenkonzo'** kusingisele kumntu ohlala kwesi sakhiwo apho umasipala avume ukuzisa iinkonzo, okanye osazisa iinkonzo, okanye, xa kungekho mntu uhlala apho, kube ngumnnini-sakhiwo;

**'usuku'** kuthetha usuku lwekhala, kubandakanya imiGqibelo kanye neecawa kanye neeholide zoluntu;

**'umnini-tyala'** kutsho nawuphi na umntu onoxanduva lokwenza intlawulo kwamasipala yetyala layo nayiphi na imali, kubandakanya-

- (a) irhafu;
- (b) intlawulo yenkonzo zakwamasipala eziziswa ngumasipala okanye elinye iziko okanye omnye umntu ngokuphathelele kwisivumelwano sokuhambisa inkonzo; okanye
- (c) nayiphina enye intlawulo enokubizwa nguMasipala;

**'oxhomekekileyo'** kuthetha nawuphina umntu oxhomekeke komnye ngenkxasoyezemali.

**'umhla lindelekileyo'** mayela –

- (a) irhafu elindelekileyo ngokunxulumene nempahla okanye izakhiwo ezingenakufuoluswa, kubhekisa kumhla wokugala kaJulayi womnyakamali lowo;
- (b) intlawulo yenkonzo elindelekileyo ngokunxulumene nempahla engenakufuduswa nezakhiwo, ibhekisa kumhla wesixhenxe enyangeni ephambi kwenyanga inkonzo ezinikezwe ngayo.

ngaphandle kokuba lomhla ungoMgqibelo, iCawa okanye iholide kawonkewonke ekothi imini elandelayo ithathwe ujengomhla wentlawulo.

**'inkqubo yesibonelelo sabasweleyo'** ibhekisa ekuncedweni kwabaasweleyo ngokomgaqo kaMasipala

**'iyanga'** kuxelwa iyanga yonyaka

**'umyinge wenkcitho ngenyanga'** kuthetha oko kuthi kusetyenziswe ngenyanga ngokunxulumene nempahla nezakhiwo kubalwa ngokomyinge othe wasetyenziswa kwinyanga ezitandathu esidlulileyo;

**'Ityala likaMasipala'** kuthetha ityala emalibhatelawe ngokubhekiselele kwinkonzo nentlawulo ezihlawulwa ngulowo uzisebenzisayo;

**'Indawo zokuhlawula'** kuthetha nayiphinina indawo apho kukho i-ofisi zikaMasipala nendawo apho kuhlawulwa khona izivumo zamatyala okanye nayiphina indawo apho.

**'Inkonzo zikaMasipala'** ezi zinkonzo ezinikezwa nguMasipala okanye lowo mbutho okanye umntu ozizisayo ngokwesivumelwano ezi njengezi amanzi umbane, ugutuulo, ubutho lwenkunkuma nezinye.

**'uMasipala'** ubhekisa kuMasipala waseNgqushwa osekwe ngokomthetho iMunicipal Structures, 1998 (Umthetho No.117 ka 1998) ibandakanya ukusekwa ubumi bezopolitiko, ilungu likarhulumente neKansile.

- (a) Igosa lezemali liye libize intlawulo yangaphambili elingana ne 1½
- (8) ngokuphindiwey intlawulo yenyanga
- (9) Igosa lezemali lisenokuyinyusa imali yentlawulo ebhatalwayo
- (10) Ukuba igosa lezemali lifuna ukuyinyusa intlawulo yomnikazi wokhupa isaziso esinka izizathu zoko
- (11) Umnini ukuba akakholisekanga kwisithuba sentsuku ezilushumi usekwenza isicelo esiphika oko
- (12) uManejala kaMasipala wothi kwisithuba sentsuku ezintlanu amva kokufumana isibheno anike impendulo engenakuphikiswa
- (13) Igosa lemali linokuthi ngokunxulumene nomhlaba wezaboshishino amkele itsheki eqinisekisiwego yibanka njenge dipozithi
- (14) Abanini mashishini balindela ukuba 250% njengomyinge wenyanga osesenzisiwego xa intlawulo ingekho ngaphantsi kweR500.
- (15) Umnikazi-shishini ngokunxulumene nediposithi engaphezu kweR100 000 unako –
  - (a) ukuhlawula 250% yonyinge woko kusetyenzisiwego ngenyanga
  - (b) okulingana we 1½ yentelekelelo yenyanga yoko kusetyenzisiwego ehlawulo ngemali ezinkozo aze athi imali eshiyekileyo asebenzise itsheki ukuyibhatala ukuba uyavumelana nesigqibo.

- (2) Ilungelo likaMasipala ukunqumamisa nokuphelisa inkonzo yombane namanzi ay nakweyiphina indawo lobaphantsi kolawulo lwenkqaku 4(3) Water Services Act 1997 (Umthetho 108 ka 1997) kwanenkqaku 11 Iwe Electricity Act, 1987 (Umthetho No.41 of 1987)

  - (c) ugutuulo
  - (d) ukuqokelelwa kwenkunkuma
  - (e) intlawulo yengqesho, ukuba ikho kwakunye
  - (f) nerhafu kwabo banemihlaba.
- (3) uMasipala uyakumana eWenga-hlengisa inkxaso yakhe kwisithuba senyanga ezintandathu, eqinisekisa ngenani labenza izecelo nemeko yakhe yezemali

- (4) Ubungakanani benkxaso enikwa nguMasipali ayisayi kudlela leyo mali ibizwa ngeyanga kwabangakwazi kuhlawula
