The Ngqushwa Local Municipality hereby invites nominations for members of the public to be appointed to serve as members of the Ngqushwa Local Municipality Municipal Planning Tribunal (NLM MPT) in terms of Section 34 of the Ngqushwa Local Municipality Spatial Planning and Land Use Management by-law, 2016 read together with Section 35 (1) of the Spatial Planning and Land Use Management Act, 16 of 2013 (SPLUMA).

**Term of Office:** The period of office of members will be five (5) years calculated from the date of appointment of such members by the Ngqushwa Local Municipality Council.

Environment	A registered environment practitioner registered with any of the following associations: SACNASP, CEIM and IAIA	Environmental Planning (10 years' experience)
Legal	A person admitted as an attorney in terms of the attorneys Act, 53 of 1979 or advocate of the supreme court in terms of the Admission Act 74 of 1964	Property Registration (10 years' experience)

Knowledge of municipal performance management systems will be an added advantage and /or you must have relevant and applicable knowledge of law in so far as relates to the land development applications, administration and town planning related matters.
